## MORAL CODE OF CONDUCT

College Students' Union members to be elected alongwith DUSU Election 2025 should abide by the following rules for smooth conduct of union functions.

- Student Union members are expected to show due respect towards the Student Advisory Board members and mind their language, conduct and behavior when speaking to the Board members.
- For joint meeting with the Board, union members should strictly adhere to the meeting schedule and time and ensure that punctuality is maintained so that precious time is not lost in waiting. All meetings should be minuted and signed by Union office bearers and Board members.
- All expenditures for the programmes/functions of the union should be met within the allocated Union budget and no request for additional funds will be entertained.
- All expenditures will be done as per the procedure laid down by the Accounts Section. For all expenditure prescribed government procedure will be followed.
- All payments to the vendors will be made through cheque only. No cash payments are allowed. For petty expenditures, proper receipt/bill should be taken from the vendors.
- An initial advance payment upto Rs 5000/- or (Rs 10,000/-) will be made to the Union for petty expenses. Further amount will be released upon submission of bills and proof of expenditures of earlier advance.
- List of sponsors should be approved a priori by the College authorities. Alcohol, cigarette, soft drink manufacturing companies are strictly NOT allowed as sponsors for any activity.
- Celebrity singers/musical band are not encouraged. However, if budget permits then prior approval should be taken by the Board.
- No Chief Guest/political leaders as guests are allowed for any of the Student Union programmes.
- In no case, Complimentary Passes will be issued to the Student Union bearers to invite outsiders including ex-students of the college. Outside students will be allowed entry ONLY with valid Identity Cards.
- For programmes involving quiz, debate, sports, cultural activities, college societies such as Arts and Culture Society, Debating Society, Quiz Society, etc. should be involved and convenors of these societies should be consulted.
- Decency should be maintained in the choice of song and dance performances and artists should restrict their performance only to the stage and in no case should try to reach audience.
- JAM Session is not encouraged.
- Proper arrangements for Pandal/tent/Audio systems will be made and supervised by college in consultation with Student Union members.
